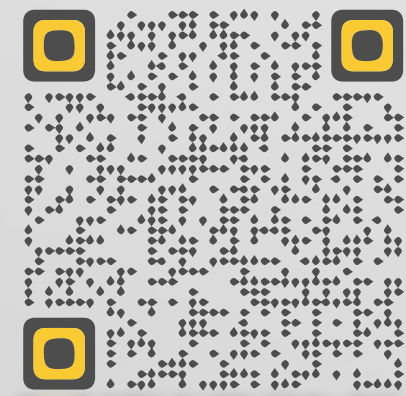

SAFETY NOTICE

DRILLING INTO CONCRETE CAN GENERATE SILICA DUST, WHICH CAN LEAD TO SERIOUS HEALTH ISSUES SUCH AS LUNG CANCER, SILICOSIS, CHRONIC OBSTRUCTIVE PULMONARY DISEASE, AND ASTHMA. BEFORE PROCEEDING WITH DRILLING, IT'S CRUCIAL TO EVALUATE THE RISK ASSOCIATED WITH SILICA DUST.

HERE ARE THE RECOMMENDED MEASURES TO CONTROL SILICA DUST:

- USE ADEQUATE WATER SUPPRESSION TO PREVENT THE FORMATION OF DUST CLOUDS.
- EMPLOY ON-TOOL EXTRACTION AND INDUSTRIAL VACUUM CLEANERS WITH HEPA FILTERS TO EXTRACT DUST DIRECTLY AT ITS SOURCE.
- IF DUST CLOUDS CANNOT BE FULLY PREVENTED OR EXTRACTED, WEAR RESPIRATORY PROTECTIVE EQUIPMENT (RPE) WITH AN ASSIGNED PROTECTIVE FACTOR (APF) OF 20 OR HIGHER.
- ADDITIONALLY, UTILIZE PERSONAL PROTECTIVE EQUIPMENT (PPE) TO SHIELD SKIN AND CLOTHES FROM CONTACT WITH DUST IF NECESSARY.
- ISOLATE THE WORK AREA WITH SHEETING OR SCREENING TO CONTAIN DUST AND PREVENT ITS ESCAPE INTO THE SURROUNDING ENVIRONMENT.
- CLEANSE SKIN, CLOTHING, AND TOOLS THOROUGHLY BEFORE LEAVING THE WORK AREA TO AVOID SPREADING DUST.
- DISPOSE OF DUST WASTE, FILTERS, RPE, AND PPE IN COMPLIANCE WITH FEDERAL, STATE, AND LOCAL REGULATIONS.
- IMPLEMENT A HEALTH SURVEILLANCE PROGRAM IN CASES OF REGULAR EXPOSURE TO SILICA DUST.

HIER SIND DIE EMPFOHLENEN MAßNAHMEN ZUR KONTROLLE VON SILIKASTAUB:

- VERWENDEN SIE ANGEMESSENE WASSERDÄMPFUNG, UM DIE BILDUNG VON STAUBWOLKEN ZU VERHINDERN.
- SETZEN SIE ABSAUGSYSTEME DIREKT AM WERKZEUG UND INDUSTRIESTAUBSAUGER MIT HEPA-FILTERN EIN, UM STAUB DIREKT AN DER QUELLE ZU ENTFERNEN.
- WENN STAUBWOLKEN NICHT VOLLSTÄNDIG VERHINDERT ODER ENTFERNT WERDEN KÖNNEN, TRAGEN SIE ATEMSCHUTZGERÄTE (RPE) MIT EINEM ZUGEWIESENEN SCHUTZFAKTOR (APF) VON 20 ODER HÖHER.
- NUTZEN SIE ZUSÄTZLICH PERSÖNLICHE SCHUTZAUSRÜSTUNG (PPE), UM HAUT UND KLEIDUNG BEI BEDARF VOR KONTAKT MIT STAUB ZU SCHÜTZEN.
- ISOLIEREN SIE DEN ARBEITSBEREICH MIT FOLIEN ODER NETZEN, UM DEN STAUB EINZUDÄMMEN UND DESSEN AUSTRETEN IN DIE UMGEBUNG ZU VERHINDERN.
- REINIGEN SIE HAUT, KLEIDUNG UND WERKZEUGE GRÜNDLICH, BEVOR SIE DEN ARBEITSBEREICH VERLASSEN, UM EINE VERBREITUNG VON STAUB ZU VERMEIDEN.
- ENTSORGEN SIE STAUBABFÄLLE, FILTER, RPE UND PPE GEMÄß DEN BUNDES-, LANDES- UND LOKALEN VORSCHRIFTEN.
- IMPLEMENTIEREN SIE EIN GESUNDHEITSÜBERWACHUNGSPROGRAMM BEI REGELMÄßIGER EXPOSITION GEGENÜBER SILIKASTAUB.

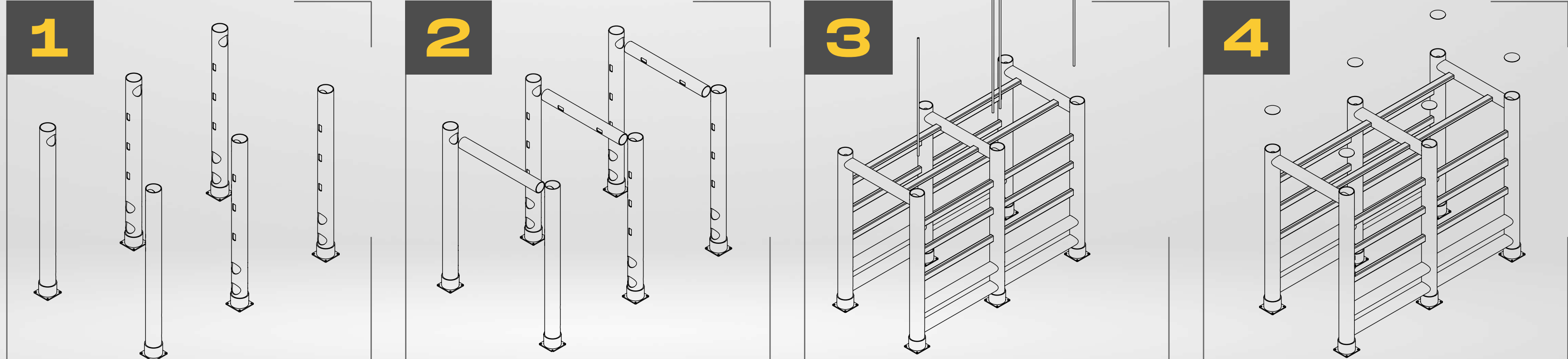

- SI LES NUAGES DE POUSSIÈRE NE PEUVENT PAS ÊTRE ENTIÈREMENT PRÉVENUS OU EXTRAITS, PORTEZ UN ÉQUIPEMENT DE PROTECTION RESPIRATOIRE (RPE) AVEC UN FACTEUR DE PROTECTION ATTRIBUÉ (APF) DE 20 OU PLUS.
- DE PLUS, UTILISEZ UN ÉQUIPEMENT DE PROTECTION PERSONNELLE (EPP) POUR PROTÉGER LA PEAU ET LES VÊTEMENTS CONTRE LE CONTACT AVEC LA POUSSIÈRE, SI NÉCESSAIRE.
- ISOLEZ LA ZONE DE TRAVAIL AVEC DES FEUILLES OU DES ÉCRANS POUR CONTENIR LA POUSSIÈRE ET PRÉVENIR SON ÉCHAPPEMENT DANS L'ENVIRONNEMENT.
- NETTOYEZ BIEN LA PEAU, LES VÊTEMENTS ET LES OUTILS AVANT DE QUITTER LA ZONE DE TRAVAIL POUR ÉVITER DE RÉPANDRE DE LA POUSSIÈRE.
- ÉLIMINEZ LES DÉCHETS DE POUSSIÈRE, LES FILTRES, RPE ET EPP EN CONFORMITÉ AVEC LES RÈGLES FÉDÉRALES, ÉTATALES ET LOCALES.
- METTEZ EN ŒUVRE UN PROGRAMME DE SURVEILLANCE DE LA SANTÉ EN CAS D'EXPOSITION RÉGULIÈRE À LA POUSSIÈRE SILICIEUSE.
